(Employee count based on total employees nationwide including full time equivalent, independent, and sub-contractors. Each general membership includes the right to one vote, hold office, and chair committees.)
- Non-Profit** - \$750
(Non-profit institutions or non-governmental entities utilizing or promoting solar energy. Excludes trade schools, community colleges and universities. Includes the right to one vote, hold office and chair committees.)

- Associate** - \$500
(Service category including: Energy audit professionals, architects, engineering and legal firms, governmental agencies, crane operators, and accredited educational institutions. Solar installation companies or employees of those companies are not eligible. Non-voting membership / ineligible to hold office or chair committees.)
- Friend of Solar** - \$50
(Friends of Solar is an individual membership. Qualifying entities include: residential system owners, commercial system owners, individuals, and students enrolled in an accredited educational institution. Non-voting membership / ineligible to hold office or chair committees.)
